To provide a Penalty Assessment Matrix to all employees as a mechanism to enable the fair and equitable handling of employee discipline.

2. Policy

Commanders will be guided by the Penalty Assessment Matrix when determining disciplinary measures to be imposed for administrative misconduct of personnel other than Law Enforcement Deputies. The Matrix is a framework for the purpose of providing consistent and fair penalties to all employees, when necessary, unless adherence to the Matrix will result in an injustice to the Harford County Sheriff's Office or the employee. For Law Enforcement Deputies, refer to HCSO policy PER 0216.
